

2010 FOOD VENDOR REGISTRATION

Space available on a first come, first served basis. We limit the number of food vendors and there will be no duplication of food types. Along with your application you must submit a proposed itemized list of menu offerings. Gates open on Friday, May 21, 2010 at Noon for food booth(s) set up. All vendors must be set up and operating no later than Saturday, May 22 at 11:00am (when gates open to the public). Vendors must vacate Fairgrounds by 8:00pm on Sunday, May 23.

Two day minimum required (Saturday and Sunday) at \$500.00 total per space, due in advance. The Fairgrounds requires \$200.00 of the \$500.00 rental amount which we include in the total. All food vendors must provide proof of insurance* and a copy of their current Monterey County Health Permit along with this application, submitted in advance to Gateway Center.
